

About Pocatello Regional Transit (PRT) and "ads that move"...

PRT provides public transit fixed route and door-to-door services. We serve communities throughout Southeast Idaho including Bannock County, Bear Lake County, Bingham County, Caribou County, Franklin County, Oneida County, and Power County.

Our buses collectively travel nearly 600,000 miles performing around 250,000 passenger trips annually. We cover a lot of ground so if you're looking for great exposure at a reasonable price, we've got what you're looking for.

PRT is a recipient of Federal Transit Administration (FTA) grants which requires local matching funds. These funds come from contributions, donations, and other revenue sources like bus advertising. So, when you advertise with PRT, you become a team player in increasing mobility for individuals and communities.



LARGE BUS - WRAPS

FULL / 6 Month Minimum *Full or partial wrap(s) on entire bus	\$650/month
HALF / 6 Month Minimum *Full or partial wrap(s) on two (2) sides of bus	\$550/month
QUARTER / 6 Month Minimum *Full or partial wrap(s) on one (1) side or rear of bus	\$300/month









SMALL BUS - WRAPS

FULL / 6 Month Minimum *Full or partial wrap(s) on entire bus	\$350/month
HALF / 6 Month Minimum *Full or partial wrap(s) on two (2) sides of bus	\$250/month
QUARTER / 6 Month Minimum *Full or partial wrap(s) on one (1) side or rear of bus	\$150/month









SIGN-SIZE BOARDS/WRAPS

1 to 3 Months	\$120/month
4 to 6 Months	\$110/month
7 or more Months	\$100/month







LARGE BUS - INTERIOR SIGNS

1 to 3 Months	\$25/month
4 to 6 Months	\$20/month
7 or More Months	\$15/month

- *All rates are on a space available basis.
- *Materials must be waterproof and wear resistant.
- *No charge for interior public service signs on approval.
- *Content should be appropriate/neutral for all audiences and is subject to approval.
- *Contracting party is responsible for design, production, installation, and removal of wraps.
- *The Director of Pocatello Regional Transit shall be authorized to offer special discounts and rates to promote the City of Pocatello and the various City departments and services provided, as the need arises.
